1.4 Uses & Restrictions

- Identified Uses: Chemical synthesis intermediate, polymer monomer, laboratory reagent.
- Uses Advised Against: Food contact (unapproved), medicinal purposes, unventilated enclosed space use.

SECTION 2: Hazards Identification

SECTION 3: Composition/Information on Ingredients

- Substance / Mixture: Pure substance (stabilized)
- Active Component: Acetaldehyde (CAS 75-07-0)
- Concentration: $\geq 99.0\%$
- Stabilizer: Methanol (CAS 67-56-1) (3-5%)
- Impurities: $\leq 1.0\%$ (Water, acetic acid)

SECTION 4: First Aid Measures

- Inhaled: Move to fresh air; give oxygen if needed; seek emergency medical attention.
- Skin Contact: Rinse with running water for 15 minutes; remove contaminated clothing.
- Eye Contact: Rinse with plenty of water for 15 minutes; seek emergency medical attention.
- Swallowed: Do not induce vomiting; rinse mouth with water; seek immediate medical attention.

SECTION 5: Firefighting Measures

- Suitable Extinguishing Media: Dry powder, CO₂, foam, water spray.
- Special Hazards: Extremely flammable vapor; forms explosive mixtures with air; toxic fumes (CO) when burned.
- Advice for Firefighters: Wear self-contained breathing apparatus and full protective clothing.

- Personal Precautions: Evacuate non-essential personnel; wear full PPE; eliminate ignition sources.
- Environmental Precautions: Prevent entry into drains/watercourses; use absorbents to contain contamination.
- Clean-Up Methods: Small spills: Absorb with inert materials; large spills: Contain and transfer to sealed containers.

- Handling: Operate in well-ventilated areas with explosion-proof equipment; use anti-static tools.
- Storage: Cool, dark, well-ventilated warehouse ($\leq 10^{\circ}\text{C}$); sealed, away from heat/sparks/oxidizers.
- Incompatibilities: Strong oxidizers, acids, alkalis.

SECTION 8: Exposure Controls/Personal Protection

- PPE: Chemical safety goggles/face shield; nitrile rubber gloves; organic vapor respirator (P100).
- Exposure Limits: TWA (8h): 25 ppm (OSHA); STEL (15min): 37.5 ppm (OSHA); IARC Group 2B.

- Physical State: Liquid; Color: Colorless; Odor: Pungent fruity

- Stability: Stable with methanol stabilizer; polymerizes at room temperature without stabilizer.
- Hazardous Reactions: Reacts violently with strong oxidizers/acids; forms explosive peroxides.

- Acute Toxicity: Oral (Rat, LD₅₀): 1930 mg/kg; Inhalation (Rat, LC₅₀): 3650 ppm (4h)
- Skin/Eye Irritation: Moderate skin irritation; serious eye irritation.
- Chronic Toxicity: Suspected carcinogen; long-term exposure may cause respiratory damage.
